## Rules and Regulations

Renters of an Elmbrook cabin are obligated to abide by all the rules and regulations set forth by the Wisconsin Department of Natural Resources, The Department of Wisconsin - American Legion, Camp American Legion Committee or Elmbrook Cabin Committee.

The Camp Director reserves the right to evict any person who creates a disturbance, nuisance or deliberately breaks any of the following rules. No refunds of the rental costs will be made in the event of such circumstances.

1. Upon arrival, cabin occupants are required to register and pick-up cabin key at the Camp Director's office located in the Main Lodge, at Camp American Legion. The office is open every day from 8:00 am until 5:00 pm. The Camp is located on County Hwy D.
2. The renting veteran shall remain in residence during the entire rental period.
3. No wood cutting or removal of branches from any trees alive or dead is permitted.
4. No fires or open flames are permitted, with the exception of charcoal or propane grills used for outdoor cooking. Grilling will be in accordance with local authorities and imposed fire bans in the area.
5. Garbage and trash must be sorted and placed into the appropriate dumpsters located on Thrush Road.
6. Public intoxication will not be permitted. All local and state laws will apply.
7. Absolutely no fireworks or firearms are permitted in or around the cabins. This includes BB and pellet guns.
8. Pets are permitted, but must be attended to and kept on a leash, at all times. Clean up after your pet's "nature calls."
9. No ATVs or dirt bikes are permitted in the area.
10. Swimming is only allowed in designated areas. No lifeguard is on duty – parents and guardians must supervise their children under the age of 13, at all times.
11. No boats or watercraft are permitted in the beach area and must comply with DNR laws.
12. RVs are to be used for transportation only, not accommodations. No tenting is allowed.
13. Occupancy of each cabin is limited to 6 persons, with the exception of two (2) additional young children. Please use discretion and common sense in inviting guests not staying at your cabin. Over tasking of the septic system will cause sewage backups, inconvenience and additional expense.
14. Saturday check-in time is after 2:00 pm and check-out is 9:00 am in order that proper cleaning of your cabin may occur. Please return the cabin key to the Camp's office.
